### **Tests Supply Voltages**

Remove all Control cable connectors (Analog and Digital Input/output connectors) from HLC1, HLC2. While Switch ON Battery supply observe is there any MCBs tripping. Wait for one or two minutes after switching ON Circuit breaker(MCB1) and observe for any overheating symptoms like smell, smoke, temperature etc. from the wire bunches. If any such symptoms are noticed, there might be a short circuit in the wire bunch. Check up once again continuity wherever suspected. ### 6. Converter operation (ON/OFF) test

Power supply is directly available to the Hotel Load Converter via Hotel Load Converter winding (2UH1-2VH1) and (2UH2-2VH2). As soon as BLDJ is closed power will be available to the Hotel Load Converter. Connect the test jig of Hotel Load Converter to the UIC and IV Coupler.
