

# Bidding: Points to remember



Go through item description, drawing, specification, Set list, STR and other attached documents



Financial offer or any deviation should be mentioned in relevant fields only.

Read the tender conditions and clauses such as delivery schedule, inspection, warranty, packing etc




Avoid duplicity of documents/irrelevant documents





Supporting documents should be attached at relevant condition of the tender.



Clearly quote your approved drawings if any

## Bidding: Points to remember



Brand/Make should be clearly mentioned.
Avoid mentioning "0" or "Nil"




Local content declaration

Place of inspection should be as per approved work address for the subject item.



Tender specific authorization for dealers/agents

#### Common deficiencies in bids

HSN code and GSTIN are not mentioned in offer.

Local Content Certificate is not attached or not in prescribed format:

- <10 Crs: Self declaration.
- >10 Crs: Auditor/Cost Accountant Certificate.
- Local Content Certificate should be tender specific and as per Annexure 4.9 of IBD.
- Local Content Certificate can be verified at UDIN. In case of false declaration, firm can be debarred for upto 2 years.

Difference in percentage of local content declared by the firm in PLW/BLW/CLW tenders.

### Common deficiencies in bids

Place of inspection or place at which local content added is not mentioned in the offer.

Land Border Sharing Certificate is not attached or not in prescribed format (as per **Annexure 4.11** of IBD).

Non submission of relevant documents like past performance, M&P list, ISO certificate, compliance to STR/specification etc.

Reason or document attached for claiming EMD exemption is not proper

EMD not submitted by dealer/agent

# Responsiveness of bids

Validity of
Offer/Bid: Cannot
be less than tender

EMD is must (except the exempted vendors)

Payment terms: No deviation is allowed



# Policy for MSEs (1 of 2)

#### Classification of Micro, Small and Medium Enterprises

Type of Industry	Investment in M&P or Equipment does not exceed	Annual turnover does not exceed
Micro	1 Crores	5 Crores
Small	10 Crores	50 Crores
Medium	50 Crores	250 Crores

An enterprise registered with any other organization under the Ministry of MSME shall register itself under **UDYAM Registration**.

# Policy for MSEs (2 of 2)

- □ Benefits under the Public Procurement Policy
  - W.e.f. 01.07.2020, MSEs with UDYAM Registration are eligible
  - Exemption from payment of EMD, purchase preference etc.
  - $\blacksquare$  Margin of purchase preference is L1 + 15%
  - 25% qty is offered to MSEs falling within above margin
- Purchase preference to MSEs
  - A minimum 25% share out of the total annual procurement (Not in the specific tender), by Central Government Ministries /Departments/Public Sector Undertakings is to be made from MSEs.
  - Sub-target of 4% from MSEs owned by SC/ST entrepreneurs and 3% from MSEs owned by women entrepreneur.

## Preference to Make in India (10f 4)

- Policy of the Government of India
- □ To encourage 'Make in India'
- Promote manufacturing and production of goods and services in India
- Enhance income and employment
- Classification of suppliers according to local content in the product offered by them
- Certain Preferences to Local Suppliers

### Preference to Make in India (2 of 4)

#### **Definition of Local Content:**

```
Total value of the item _ Value of imported content

(excluding taxes) (including duties)

Total value of the item (excluding taxes)
```

#### Type of certification required along with bid:

- Self certification required for procurement value from Rs.5 lakhs to Rs.10 Crores.
- Certificate from statutory/cost auditor or practicing cost/chartered accountant, if procurement value > Rs.10 Crores

### Preference to Make in India (3 of 4)

#### Classification of suppliers

Type of supplier	Local Content	
Class-I local supplier	≥ 50%	
Class-II local supplier	20% ≤ Local content < 50%	
Non-Local supplier	< 20%	

- Ministry of Railways may prescribe higher %age of minimum local content for Class-I/II local supplier.
- Ministry of Railways has published lists of items where sufficient local capacity exists. Such items are restricted to be procured from Class-I local suppliers only.
- Eligibility of only Class-I or Class-I/II local suppliers is always indicated in PLW tenders.
- Tenders having estimated value less than Rs.5 lakhs are exempted from Public Procurement (Preference to Make in India) Order.

# Preference to Make in India (4 of 4)

	Non-Local supplier (Local Content< 20%)	Class-II local supplier (20% $\leq$ Local content $<$ 50%)	Class-I local supplier (Local Content≥ 50%)
Eligibility in tenders	Only Global Tenders. Not eligible for indigenous tenders.	All tenders where item is not reserved for procurement from Class-I suppliers only.	All tenders
Purchase preference  (Margin of purchase preference is L1 + 20%)	No	No	Yes  (Purchase preference for 50% qty over  Class-II local supplier as well as Non local supplier in the tenders where those suppliers are also eligible to bid.)

# PPP-MII order dt 19.07.24 (1 of 2)

#### Changes in the policy:

- Imported items sourced locally from resellers/distributors shall be excluded from calculation of local content.
- The license fees/royalties paid/ technical charges paid out of India shall be excluded from local content calculation.
- Procurement of spare parts, consumables for closed systems and Maintenance/ Service contracts with OEM shall be exempted from this Order.

## PPP-MII order dt 19.07.24 (2 of 2)

Supply of repackaged/refurbished/rebranded imported products shall be treated as reselling of imported products and shall be excluded from calculation of local content.

- "Refurbishing" means repair or reconditioning of an imported product does not amount to manufacture because no new goods come into existence.
- "Repackaging" means repacking of imported goods from bulk pack to smaller packs would not ordinarily amount to manufacture of a new item.
- □ **'Rebranding'** means relabeling or renaming or change in symbol or logo/makes or corporate image of a company/organization/ firm for an imported product would amount to rebranding.

## Other changes in tender conditions

- Security deposit to be valid till completion of warranty obligations
- A standard Force Majeure Clause is now part (para 2602) of the IRS Conditions of Contract
- Warranty Clause as per IRS Conditions: 30 months from date of delivery
- Third Party Inspection
- Stage inspection is part of PO, wherever applicable

## Raising Bills on IREPS

- While uploading bills, most of the vendors are mentioning Type of Industry as MSE. Only those vendors as have been to mention themselves as MSE.
- Copies of invoices uploaded are either not digitally signed or original invoices are not signed by authorized signatory which result in back references.
- Aggregate Turn Over statement shall be uploaded with each invoice uploaded otherwise bills have to returned.
- Correct Invoice number, Date, GSTIN number may be ensured while uploading bill to avoid any mismatch between details on IREPS and GST portal.

# Developmental Tenders

- Only new vendors are eligible. Past and approved vendors not allowed.
- Must submit the relevant documents to substantiate the capacity to develop and supply the tendered item
